CONTRACTOR REGISTRATION INFORMATION FOR 2018

Applications for registration must include the following:

- **Registration fees for 2018 by date:**
- **\$75 before February 1, 2018 -- \$100 annually after February 1, 2018 & \$50 November 1, 2018 thru December 31, 2018.**
- All applications must include a **2018 original signed or electronically sealed** Contractor's Bond with Power of Attorney. (form furnished by the City in the amount of **\$10,000**)
- All applications must include Certificate of Liability insurance with a minimum of \$100,000/\$300,000 bodily injury and \$50,000 property damage. The City of Seven Hills shall be named as a **certificate holder** and be named as **additionally insured**.
- Attach a copy of the **State of Ohio Contractor's License** associated with your operation.

*****Contractors** will be registered in **one** of these **six (6)** categories, **General, Plumbing, HVAC, Electrical, Low Voltage or Fire Suppression/Sprinkler**. These are the **only categories we will accept**. (**General Contractors** include Landscaping, Concrete or Cement, Roofing/Siding & Waterproofing Contractors, etc.) **We do not accept Riders or Stipulations to correct a Bond**. It is recommended that you get these instructions to your insurance provider in order that they follow our guidelines.

The Building Department will be enforcing the **posting of permits**. Failure to display permit may result in inspection not being performed and fines. In addition, **all required inspections must be requested and finalized or future permits will be delayed**.

We now accept Visa, MasterCard, Discover Credit/Debit cards along with checks, cash or money orders for payments of Permits and Fees.
