## **Mayor Dell'Aquila (continued):**

As everyone knows, this has been a difficult few months, with respect particularly to some of the adjustments that were made at the Recreation Center. Together we instituted a plan which resulted in a dramatic reduction in the City subsidy over there. The anticipated subsidy going into 2012 was about \$450,000.00. We found, at the end of 2012, that due to the changes that were made – modifications, adjustments, new methodologies instituted there – that subsidy has been reduced to \$75,000.00 for 2012. It's always good to have more than one set of eyes to look over one's shoulder. I thought it would be important to have a group of qualified, experienced, dedicated residents to take a look at some of the ideas we were implementing there to render an independent, unbiased opinion as to the feasibility of the changes we were implementing – whether we were missing anything. As a result of the work that this group of five advisors did, we were able to understand that the program we were implementing did have the promise of returning the result that we ultimately realized. So, again, I wanted to thank Council for allowing me the opportunity to make the presentation of these proclamations. And, at this point, I would like to acknowledge the five members of the Advisory Committee to the Mayor on the Recreation Center who participated and rendered such a great service to the City. Those gentlemen are here this evening – well, four of the five are here -- former Mayor **George Chandick**, former Finance Director **Al Lippucci**, former Councilman **Robert Leech**, Mr. **David Foley**, and Mr. **John Predina**. These five gentlemen, I believe, should be acknowledged by everyone in the room for the great service they rendered to our community, and I want to thank you for your time in allowing me to present these proclamations.

*The five members of the Advisory Committee to the Mayor on the Recreation Center received a congratulatory round of applause from everyone in attendance.*

Council President Barth stated that the Mayor appointed a very distinguished committee. Mr. Barth thanked the five gentlemen for their service on behalf of all members of Council.

*Mayor Dell'Aquila individually presented his Proclamations to the Advisory Committee members.*

Council President Barth afforded the Advisory Committee members an opportunity to address Council if they so wished.

## **George Chandick:**

One of the major individuals that isn't here with us, who did an outstanding job in really leading this entire group, was Dave Foley, and I want to recognize him now before this Council, because in his presentation to the Mayor and to a few other people, there were things that were mentioned that this Committee really hopes you will adopt at some time when the finances become available. ## **Robert J. Leech:**
