<u>PLANNING COMMISSION RECOMMENDATIONS</u> <u>Amended Ordinance No. 122-2014</u>

Council President Pro Tem Barth stated that the Planning Commission Recommendations will be provided by Planning, Zoning and Economic Development Chairman Tom Snitzky.

Mr. Snitzky made the following remarks:

"This is a required Public Hearing to make a change to Section 997.01 of the Planning and Zoning Code of the Codified Ordinances of the City of Seven Hills -- The time required for a boundary survey prior to a fence installation from five years to ten years provided the pins/markers of said survey are definable. The Planning Committee of Council basically compromised and discussed this and decided it would be a good idea to raise it out to ten years. The Planning Commission provided the recommendation that the boundary markers needed to be visible and identifiable. This was an amended ordinance that was done based upon request from residents to alleviate some of the costs of improving their property with a fence, trellis, or a wall. It was good working between the Council and the Planning Commission who made some recommendations, and we are here to enact the ordinance."
