Public notice is hereby given that the following separate Proposals will be submitted to the electors of the City of Seven Hills at the Election to be held March 15, 2016, in accordance with Amended Ordinance No. 137-2015, passed December 14, 2015, and Resolution No. 20-2015, passed December 14, 2015, by the Council of the City of Seven Hills:

**PROPOSAL** AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE ELECTORS OF THE CITY OF SEVEN HILLS, OHIO, A CERTAIN CHARTER AMENDMENT PURSUANT TO ARTICLE X OF THE CHARTER OF THE CITY OF SEVEN HILLS, OHIO, FOR THE PURPOSE OF ALLOWING THE ELECTORS TO VOTE ON THE QUESTION OF AN INCOME TAX LEVY AT A GENERAL, PRIMARY, OR SPECIAL ELECTION; AND DECLARING AN EMERGENCY.

**The ballot for said question shall be in the following form:**

Shall Article XIII, Section 2, of the Charter of the City of Seven Hills be amended to allow the electors of the City to vote on the question of an income tax levy at a general, primary, or special election?

**PROPOSAL** A RESOLUTION PROVIDING FOR THE SUBMISSION TO THE ELECTORS OF THE CITY OF SEVEN HILLS, THE QUESTION OF COUNCIL AMENDING SECTION 505.11, HUNTING PROHIBITED, AS FOUND IN CHAPTER 505, ANIMALS AND FOWL, AS CONTAINED IN PART FIVE, GENERAL OFFENSES CODE, OF THE CODIFIED ORDINANCES OF THE CITY OF SEVEN HILLS, TO AUTHORIZE A NUISANCE ABATEMENT INITIATIVE FOR BOTH SHORT-TERM AND LONG-TERM CONTROL AND REDUCTION OF THE WHITE-TAILED DEER POPULATION, IN COORDINATION WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES AND CONTIGUOUS, ADJOINING, POLITICAL SUBDIVISIONS THAT OPT TO ADOPT A SIMILAR PLAN FOR NUISANCE ABATEMENT, AND ESTABLISHING AN ELECTION DATE THEREFOR.

Shall the City Council amend Section 505.11, Hunting Prohibited, of the Codified Ordinances of the City of Seven Hills to permit the limited hunting of white-tailed deer by crossbow or long bow by licensed individuals conducted from elevated platforms, under terms and conditions established by the State of Ohio and the City of Seven Hills, and under the supervision of the Chief of Police?
